Subject:- Physical Annual Objective/targets for the year 2017-18 under SBM-G.

Sir,

Physical annual objective/targets for the year 2017-18 are fixed for each district falling in Jammu/Kashmir Division of approved activities under the SBM-G guidelines. The annual District wise objectives/targets of sanctioned activities are approved with the objective to declare the J&K State ODF by or before 2<sup>nd</sup> Oct, 2019 in case of IHHL units as the year wise roadmap in this regard has already been worked out. Physical target are approved and conveyed in Annexure 'A' & 'B' subject to the following conditions:-

1. Incentives as provided under the mission for the construction of Individual Household latrines (IHHL) shall be available for all the Below Poverty Line households, however Above Poverty Line Households restricted to SCs/STs, Small and Marginal farmers, Landless labourers with households, physical handicapped and women headed households. BPL families will be considered for benefits which are enlisted in the BPL survey list once once in time. Incentives will be provided only those families who are uploaded on the website of Ministry of Drinking Water & Sanitation ( Baseline Survey - 2012) and physical annual targets are also fixed accordingly in respect of IHHL units.
2. Community Sanitary Complex (CSC) should be taken up after completing all the codal formalities. Availability of land and its location, community share and also after owning up the responsibility of their operation and maintenance by the Community/PRI as contained in the SBM(G) guideline should be ensured.
3. All the approved SBM(G) activities will be taken up with the consultation of elected PRIs and local representatives.
4. To prepare a Block-wise/Panchayat-wise locational Action Plan of your district as per the targets conveyed in light of SBM(G) guidelines and send to this office within a week's time for technical vetting.
5. The details of works identified under Solid & Liquid Waste Management (SLWM) as per the guideline of SBM(G) and submit a separate Panchayat-wise proposal.
6. Approval of activities with the condition of availability of funds for the year 2017-18.
7. Pre, during the Post execution photographs will also be taken for the record.
8. Capturing and uploading photographs/Geo tagging of constructed latrines (IHHL) on the MIS should be done on priority as per the requirement of website module.
